

# LAL Language Centres COVID-19 Policy

### **Purpose and Scope**

This policy will cover how our operations will be affected and will ensure that staff, parents, students and agencies are aware of how LAL will handle all aspects of the programmes at our schools.

COVID-19 has created an ever-changing landscape with each government's guidelines being different and circumstances changing all the time. It is extremely important for all third-party stake holders – parents, students and agencies – to check our policy regularly for changes which may have an effect on the trip to the UK or South Africa.

The below policy is written according to current guidelines and is subject to change.

# **Policy**

It is LAL's policy to:

- Keep everyone involved in the programme safe, including venue school or university staff
- Remain compliant with government guidelines
- Minimise risk of infection amongst its student and staff body

#### **Method**

#### Prior to and on student arrival

- All areas are deep cleaned
- All equipment is disinfected
- The most recent government guidelines are known by all staff
- Contact has been made with Public Health England or NCID (National Institute for Communicable Diseases) in South Africa, in case of an outbreak
- Isolation Area has been identified
- Most recent version of the policy is posted on the website
- Staff are trained in all aspects of the policy and processes for all eventualities
- Sufficient PPE, sanitiser and other relevant medical and first aid supplies are available
- LAL's insurance cover related to COVID is identified and communicated to agencies and parents
- Comprehensive check lists are in place and adhered to

- For students on Young Learner courses or students under the age of 18 on adult courses, all parents must complete a welfare form to include parents' contact details, medical information and contact COVID-19 history
- For adult students a registration form must be completed on arrival
- LAL emergency phone number(s) are readily available to all third parties
- Pre-arrival information has been issued/published to include what students must bring e.g. masks, sanitiser
- Appropriate transport from port of entry is in place
- NHS (UK) or NCID (South Africa) and any other social distancing notices are posted around the school
- Contactless registration is in place where possible
- Risk assessments reviewed, written and made available to staff, and on the website
- Operational Procedures to be reviewed, to include the effect of COVID-19
- Pre-arrival level tests completed
- Establish source for pre-departure testing, if required, and ensure that results are received in time for departure.
- Ensuring homestay hosts are compliant with all COVID-19-related procedures

# **During the Programme**

- Students are advised of all procedures relating to COVID-19
- Students must download the NHS COVID-19 App
- Sanitising products are always available in all communal areas
- Social distancing to be adhered to (according to UK government policy)
- Mask wearing to be adhered to (according to UK government policy)
- Regular deep cleaning of all areas
- Regular cleaning of all equipment
- Regular temperature taking (on entry to the school building)
- For all students under the age of 18, regular meetings with pastoral staff
- Students to be placed in "bubbles"\*
- Activities and excursions to be carried out within bubbles
- Activities and excursions to take place outside where possible
- Leisure providers to supply their own Covid risk assessment prior to the visit and staff ensure guidelines are adhered to during the excursion.
- Comply with external governments' requirements for student and/or group leader repatriation e.g. testing prior to departure\*\*

<sup>\*</sup> A bubble is a group (size of group to be determined nearer the time) of students who are isolated from the rest of the students such that they do not come into direct contact (less than 2 metres)

\*\* Any testing will be at the student's expense unless the test is paid for by the government

# **After the Programme**

 If student has symptoms or tests positive, we will need to be informed immediately

# **Current Government Roadmaps**

#### UK

At the time of writing, the government has introduced a plan to open up most of society on or after 21 June, 2021. The steps phase out various restrictions which are currently in place. Each step will be reviewed and they are subject to changes, depending on infection, death and vaccination rates and efficacy.

#### **South Africa**

South Africa is currently under Alert Level 1 lockdown restrictions. This is subject to changes, depending on infection, death and vaccination rates and efficiency.

# **Procedure for COVID-19 Symptoms and Testing**

The facts surrounding this procedure are subject to change, according to government guidelines so will be published nearer the time of the programmes.

If the student is due to return home during a period of self-isolation, it is the agency or the parent's responsibility to change any return flight.

Additional costs for changing a flight are at the student's expense and these are not covered by LAL's insurance.

#### **Other Information**

- The UK government intends to have all UK resident adults vaccinated by 31 July, 2021
- For young learner courses, a checklist created by members of YL EUK, a special interest group of EUK schools, will be used to ensure that the schools are as COVID-safe as possible
